# Introduction

Park Forest was one of the first five participating municipalities in the “Aging in a Changing Region” program, run by the Metropolitan Mayors Caucus, the Chicago Metropolitan Agency for Planning and Planning/Aging, funded by a grant from the RRF Foundation for Aging. Throughout 2021, Planning/Aging led public meetings in each municipality to obtain community input on how aging-in-community might be better supported.

One consistent theme – first articulated by residents in Park Forest, and later reiterated in every municipality – was the need for a single resource to which older residents or those who assist them could turn to find relevant factual and contact information for local supports and services to help age in their homes and the community. Sourcing, aggregating, verifying, and updating such information represents a significant task for individuals.

This topically organized document represents CMAP's initial foray into preparing such a one-stop, single-source Handbook. It was developed in partnership with key Park Forest staff and stakeholders and with resident input on May 5, 2022, Summit. During the Summit, attendees identified the following themes: Guide

Format, Distribution, Guide Content, Programs and Resources that already exist, Best Practices from other organizations, and other ideas/programs for the Village to consider. CMAP, and its Aging in a Changing Region partners are pleased to present this Handbook, both to support Park Forest residents as they age-in-community, and in the hope that it can serve as a template for the development of similar documents throughout the region.

Park Forest offers various support services to address the diverse needs and interests of older adults, from those who are active and healthy, to those residing in long-term care facilities and seniors who are fragile and may be restricted to their homes. The following resources are a combination of local government, social services agencies, and medical offices, both nonprofit and private businesses. Most of the resources are within the Village, but we have included a few more outside of Park Forest for additional resources. Neither the Village nor Aging in a Changing Region endorses any private or local business, but wanted to include all resources needed and provided by the accessible to Park Forest residents.





### Disability Status



# Housing Options

Older populations begin to face many housing challenges, including those related to affordability, physical accessibility, and access to medical and other services inside and outside the home. This section provides the contact information for various housing options ranging from independent living to assisted living available for seniors in Park Forest and surrounding areas. The term “senior housing” is often used to describe any one of multiple types of housing geared to people over age 55 or 62 years. However, many senior housing categories target different market niches, so it is helpful to clarify these housing types. This section also contains contact numbers for common house repairs and building modification services.

## **Active Adult Retirement Community**

Active adult communities are usually geared to those ages 55+ and have restrictions on children living in the community full-time. They attract people in their 60s and early to mid 70s at move-in. Active adult communities are geared to those who can live independently, prepare meals, and care for their own homes. They offer a high level of common area recreational amenities, usually including a large clubhouse and pool, and often are built around a golf course. Limited social services are provided.

## **Independent living**

These are free standing buildings restricted to those age 62+ but are occupied primarily by those in their 70s and 80s. They are more likely to be rental properties with studio, one and two-bedroom apartments. Amenities may include a community or multipurpose room, exercise equipment, computers, and some activities. Meals are not included, though some properties will make arrangements for meals for an additional fee.

## **Independent Living – Congregate Care**

These buildings are restricted to those aged 62+ but are occupied primarily by folks in their 70s, 80s, and 90s. The buildings are

usually rentals and have a mix of studio, one and two-bedroom apartments. The difference between this type of housing and independent living described above is that these buildings include some or all meals. The monthly fees are significantly higher than at the independent living facilities where meals are not included. These buildings have many amenities and activities and often have their bus to take residents on shopping and other trips.

## **Assisted living**

Assisted living facilities to cater to seniors needing assistance with several activities of daily living (ADLs), such as dressing, bathing, medication management, walking, eating, toileting, etc. Residents are usually over 75, and most are in their 80s and 90s. These facilities provide a high level of care, including three daily meals, services, and activities. A significant difference is that assisted living facilities are licensed by the state, while independent living is not. Usually, Medicaid covers the cost for low-income residents who turn over their monthly earnings for rent (generally from Social Security, pensions, etc.). However, they are allowed to keep \$90 per month for spending money.

# Housing Options *continued*

## Continuing Care Retirement Community (CCRC)

CCRCs typically provide three levels of care – independent living, assisted living, and skilled nursing. They can include independent apartments, cottages, assisted living apartments, and nursing home rooms. They usually require an entry fee plus a monthly fee. Unlike a condominium, residents do not buy a fee for simple interest in their unit. CCRCs have a high level of amenities and services.

## Nursing Homes

Free-standing nursing homes are for residents who cannot live independently, need assistance with a wide range of personal services, and have health problems requiring 24-hour care. Residents typically have semiprivate rooms, though more are renovating and providing private rooms. Some nursing homes will accept patients on Medicaid, where the government pays the fees once a person has exhausted their assets.

- Roofing installation or repair/replacement
- Siding, soffit, and gutter installation or repair/replacement
- Concrete driveway work (curb cut fee may be required)
- Asphalt driveway (curb cut fee may be required)
- Bathroom modifications
- Walking Ramps

If you are considering hiring a contractor, verify that they are licensed and bonded to do work within the Village of Park Forest. All contractors working within the Village of Park Forest are required to be licensed through the Village.

# Transportation

There are public transportation options through the townships and some nonprofit organizations. Township services are usually available only for trips within the township, but the communities are in multiple townships and two counties. As such, there is a need to coordinate transportation across township and county lines for trips other than medical appointments.
