To support the public safety and electrification initiatives that are vital in communities throughout northeastern Illinois, ComEd and the Metropolitan Mayors Caucus are proud to share that grants of up to \$10,000 were awarded to 21 communities through the Powering Safe Communities program.

Since 2016, ComEd has collaborated with the Metropolitan Mayors Caucus, to fund 116 local safety and electrification projects with \$850,000. The Metropolitan Mayors Caucus is responsible for program administration and ComEd generously provides the funds for the program. Grant recipients provide a match of ComEd's contribution with their own funds.

The Powering Safe Communities program intends to:

- Foster collaboration and cooperation in the community to create a culture of safety and wellness;
- Address unmet public safety needs;
- Build community resiliency and enhance preparedness;
- Improve public health outcomes;
- Enhance the quality of life in cities, villages, and towns in the ComEd region and among Metropolitan Mayors Caucus member communities;
- Enable local governments to provide for the health and safety of their residents and visitors;
- And Improve public safety relative to the use and distribution of electricity.
