- Best way to be ready for programs like this is to have attempted grants like this previously



Benefits & Outcomes


- Focus on roof repairs and roof replacements
- As of today completed eight total projects; one full rehabilitation project and seven roof repair or full roof replacements
- Signed our ninth project last Tuesday morning for a full roof replacement for \$15,000 in hard costs
- Anecdotally, all of the applicants would not have been able to get these repairs or roof replacements complete but for the HRAP



IHDA – Strong Communities Program Round 2

Phase I

- Eight eligible properties in one of the Villages hardest hit neighborhoods from the recession
- Awarded \$712,000 in September 2023
- Currently in the middle of environmental inspections, remediation, roofing replacements, and getting quotes on concrete work
- SCP Round 2 supports our South Suburban Trades Initiative



IHDA – Strong Communities Program Round 2

South Suburban Trades Initiative

- The SSTI program, a joint project with the Village, South Suburban College, and Prairie State College, is funded by the Illinois Housing Development Authority when available.
- Program has rehabilitated five Village-owned houses
- All rehabilitated homes except 244 Gentry have been sold, and all expenses related to rehabilitation, project management, acquisition and sale, property maintenance, and legal fees have been reimbursed to the Capital Projects Fund.
- Net profits from home sales are added to a balance used to cover rehab expenses if proceeds and grants fall short, ensuring the SSTI program has a net zero impact on the Capital Projects Fund.
 - The latest SSTI home, 76 Winslow, was sold in August 2023.

South Suburban Land Bank & Development Authority

- Mission: To reduce vacancy, stabilize the tax base, and enhance economic activities in the Southland Region through the acquisition and redevelopment of distressed properties in partnership with local governments.
- How they work Acquire, Absolve, and Activate
- In 2023 alone, the Land Bank secured an estimated \$452,816 in property tax revenue for our member communities by taking vacant properties and returning them to productive use.
- Park Forest will have about 60 properties go through the SSBLDA process by the end of 2024
